Pumped 10 bbls mud clean, 10 bbls FW w/red dye in the last 5 bbls. Then pumped 200 sx (281.9 cf - 50.2 bbl slurry) Type 3 cement w/2% CaCl2 & 1/4#/sx Cello-flake. Dropped plug and displaced with 25.3 bbls FW. Circulated 9 bbls cement to surface. WOC. NU WH, BOP & lines. PT - good test.
