Tail - pumped 20 sx (32.6 vf - 5.8 bbl slurry) Type 3 cement 35/65 POZ w/6% gel, 10#/sx CSE, 0.02#/sx Static Free, 0.75% FL-52, 0.2% CD-32, 1/4#/sx Cello-flake. Dropped plug & displaced w/95.9 bbls FW. Set ECP, dropped bomb to open DV tool.

Pumped 2nd Stage - Lead - 10 bbls FW w/red dye ahead of Lead - 140 sx (336.9 cf - 60 bbl slurry) Type 3 35/65 POZ w/6% gel, 3% KCL, 0.4% FL-25, 5#/sx LCM-1, 1/4#/sx Cello-flake, 10#/sx CSE, 0.02#/sx Static Free. Tail - Pumped 50 sx (69.6 cf - 12.4 bbl slurry) Type 3 cement w/1/4#/sx Cello-flake, 1% CaCl2. Dropped plug & displaced w/83.2 bbls FW. Plug down @ 0821 hrs 4/14/01. Bumped plug w/1700 #. WOC. ND BOP, set slips and cut off casing. RD & released rig. Will show TOC and casing pressure test on next report.
