RIH w/8-3/4" bit & tagged cement @ 292'. Drilled cement to 331'. Drilled ahead to 3159'. COOH. Tried to circ. Hole not stable. Tried to RIH w/7" 20#, J-55 casing, only able to get casing to 2986' with ECP set @ 2807'. RU to cement. Pumped 20 bbls water, 10 bbls mud clean & 20 bbls water ahead of 1st stage - 20 sx (28 cf - 5 bbl slurry) Type 3 w/1% CaCl2 & 1/4#/sx Cello-flake. Displaced w/119 bbls water. Plug down w/150#. Inflated ECP to 1600#. Opened DV tool.

Second stage. Pumped 20 bbls water, 10 bbls mud clean, & 20 bbls dye water ahead of 400 sx (954.5 cf - 170 bbl slurry) Type 3, 35/65 POZ, w/6% gel, 1/4#/sx Cello-flake, 5#/sx LCM-1, 10#/sx CSE, 3% KCl, 0.4% FL-25, 0.02#/sx Static Free. Tail - pumped 80 sx - 112.3 cf - 20 bbl slurry) Class H cement w/0.75% FL-62, 0.2% CD-32, 0.2% Metasilicate, 5#/sx LCM-1, 1/4#/sx Cello-flake. Dropped plug & displaced w/112.8 bbls water. Plug down @ 0245 hrs 3/19/01. Circ. 1 bbls cement to surface. ND BOP, set slips and cut off casing. NU BOP & Manifold. PT to 200# - 3 minutes and 3000# for 10 minutes. Good test.
