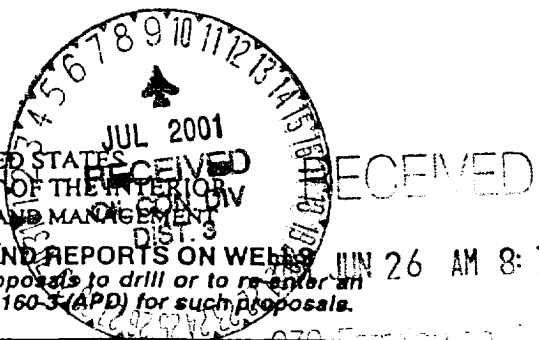

The Fruitland Sand was perforated on 5/18/01 from 1696'-1700', 1712'-1723', 1738'-1744', 1758'-1776', 1818'-1827', 1834'-1844', 1847'-1851', 1872'-1878', 1882'-1891', 1912'-1916' w/ 4SPF, 324 Holes (81'), EHD = 0.38', in the 4 1/2" casing. On May 25, 2001, American Energy Services fracture stimulated the well with 98,900 gals. of Amber 1020 Gelled water w/ 103,000 lbs of 12/20 Brady Sand proppant, SIP 1100 psig, Flow back 110 BLW and well dred. On 5/31/01 ran bailers to clean out sand (360'), ran 2 3/8" tbg and scrubbed well, rec 30BLW and well starting flowing load water w/sand, cleaned up. Shut well in to wait on pipeline connection. SITP 520 psig, SICP 640 psig.
