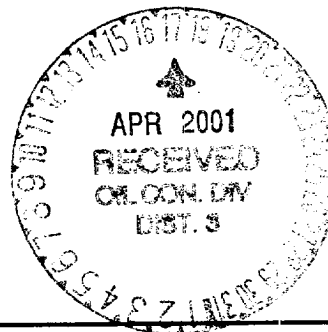

Cemented casing w/200 sx Type III cement w/2% CaCl₂, 1/4#/sx cellophane (49 barrels). Circulated 16 barrels of cement to surface.

Pressure tested casing to 1,500 psig for 30 minutes. Held okay.
