On 7/19/01, Cross Timbers ran 61 jts of 4-1/2", 10.5#, J-55 casing @ depth of 2,500' KB. The casing was cemented w/275 sx Premium Lite HS cement (12.5 ppg, 2.07 cuft/sx). Circ 15 bbls of cement to the surface. ND BOP's. Set slips. Released drilling rig on 7/19/01.
