Additional information per Rule 303C(3)(b):

- (i) Division Order that established the pre-approved pool combination is R-11363
- (ii) Basin Fruitland Coal (71629) & Aztec Pictured Cliffs (71280) Pools
- (iii) Basin Fruitland Coal perforated interval: 2,140' – 2,150'
Aztec Pictured Cliffs: 2,178' – 2,197'
- (iv) It is proposed to allocate gas sales using the subtraction method. The Pictured Cliffs has a normal decline profile. Based on production tests of the Pictured Cliffs between 9/26/01 and 10/14/01, the initial gas sales rate of the Pictured Cliffs will be 50 MCFPD. The gas rate will be declined at 10%. This is based on a typical Pictured Cliffs decline rate. Attached is a table of forecasted gas sales by month. The Pictured Cliffs forecasted gas sales will be adjusted by actual days produced over days in the month. The maximum Pictured Cliffs gas sales will be equal to the forecasted gas sales. The Fruitland Coal gas sales will be any volume in excess of the forecasted Pictured Cliffs gas sales. Condensate and water production will be allocated to each formation at the same ratio as the gas sales for each formation as determined from the above method. No condensate has been produced from either formation.
- (v) Downhole commingling will not reduce the value of the total remaining production. A longer productive life is expected due to a lower economic production limit for each pool resulting from combined production.
- (vi) Ownership is identical in both pools.
- (vii) XTO Energy, Inc has submitted a Sundry Notice Form 3160-5 concerning this proposal to the Bureau of Land Management.
