This well was spudded on 1/14/02 and an 8 3/4" hole was drilled to 695' KB. Seven (7") inch casing, new, 23 ppf, J-55 was run to 688' and cemented to surface w/ 200 sks Cls B w/ 2% CaCl₂, w/ 5#/sk Gilsomite, w/ 1/4 #bk Celloflake (236 cu.ft.), circulated 7 bbls cement to surface, fell back, topped off w/ 20 sks Cls B w/ 3% CaCl₂ (24 cu.ft.) and hole stayed full, slurry was all 15.6 ppf w/ yield of 1.18 cu.ft./sk and ran 4 centralizers with guide shoe and float collar, float held after test to 1000 psig. Installed 7" casing head, BOP, tested to 1000 psig, OK. Drilled 6 1/4" hole to 2200' DTD; ran HES logs HR Induction, Neutron-Density and Microlog. Ran new 4 1/2", 10.5 ppf, J-55 casing to 2183' KB and cemented to surface with 110 sks HLC, 220 cu.ft., 12.5 ppf, yield=2.0, tailed in w/ 150 sks B Premium w/ 3#/sk Gilsomite, 1/4 #bk Celloflake, 15.6 ppf, yield=1.18, circulated 15 bbls cement to surface, bumped plug w/ 1500 psig, float holding, OK on 1-23-02. Completion expected in next 60 days.
