

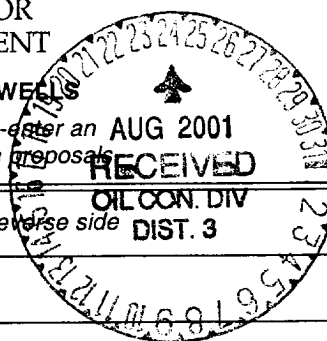

Drld to 221' KB. Ran 5 jts 7". 20#, J-55 surf csg to 219' KB. Cemented the casing with 65 sx cl "B" cmt (15.6 ppg & 1.18 cuft/sx). Circ 6 bbls cement to surface.

Pressure tested BOP & surface casing to 800 psig for 30 minutes. Held OK.

Resumed Drilling ahead.
