10-18-01 Spud 8 3/4" surface hole. Drill to 140'. Ran 4 jts 7" 20# casing to 139'. Cemented with 60 sxs Class B with 2% CaCl2. Circulated approx. 4.5 bbls to pit.

10-19-01 Test BOP to 1000#. Test casing to 600#. Drill to 880'.

10-20-01 Drill to 880' TD. Ran 20 jts 4 1/2" 10# casing RIH with 4 1/2" guide shoe

10-20-01 20 joints 4 1/2" casing. SDFN. Ran 5 centralizers, Mix and pump 50 sx 2% c-lite Class B Cement, 1/4" Cello Flake. Displace cement with 13.5 BBL water. Casing set @ 875.44, Float set @ 831.36. RDMOL
