It is proposed to surface commingle the L.C. Kelly #5M and the L.C. Kelly #8. A gas line will be laid from the L.C. Kelly #5M to the L.C. Kelly #8 well pad following the L.C. Kelly #5M access road. The distance between pads is approximately 500'. Surface commingling these wells will allow the use of a single compressor. This will reduce operating expenses, minimize surface use impact and increase ultimate recoveries. Attached for your information is a copy of the NMOCD application.
