Pumped a preflush of 10 bbls mud clean and 20 bbls water w/dye in last 10 bbls. Pumped Lead - 400 sx (964 cf - 171.68 bbl slurry) Premium Lite High Strength FM, 3#/sx CSE, #3 KCL, 0.25#/sx Cello-flake, 5#/sx LCM-1, 0.4% FL-25, 4#/sx Pheno-seal. Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl₂, 0.25#/sx Cello-flake. Displaced w/119 bbl water. Plug down @ 0640 hrs 11/10/02. Circ. 25 bbls cement to surface. ND BOP, set slips and cut off casing. NU BOP. PT-OK. RIH & PT casing to 1500 psi for 30 minutes. Good test.
