13. Describe Proposed or Completed Operation (clearly state all pertinent details including estimated starting date of any proposed work and approximate duration thereof. Drill 12 1/4" hole to 280'. On 7/21/02 ran 6 jts 9 5/8" casing. Set at 275'. Cement with 200 sacks class "B" cement with 2% CaCl2 and 1/4# flowseal sacks. Circulate 19 bbls. cement to pits.

Drill 8 3/4" hole to 3572'. On 7/25/02 ran 83 jts. 7" 23#, J-55, LT&C casing. Casing set at 3564'. Pump 98.2 bbls (380 sx) foamed class B cement 2% gel, .2% versaset & .1% dracel LWL, 75 sacks (19.4 bbls) class B 2% gel, .2% versaset, .1% diacel LWL. Circulate 25 bbls foamed cement to pit. Capped backside with 10.5 bbls, 50 sacks class B 2% CaCl2, .1% versaset.

Drill 6 1/4" hole to 7990'. On 7/29/02 ran 180 jts. 4.5#, 11.6#, J-55 casing. Set at 7965'. Cement with 560 sacks cement with 50/50 POZ, 2% GEL, 15% versaset and .1% diacel LWL as follows: 82 bbls foamed cement, tail in with 190 sacks (16 bbls) cement with no foam, displaced with 123 bbls water. Pumped 50 sacks (10 bbls) down backside. Did not get cement to surface. Top of cement 2800' by CBL. Cap cement 500'-1140' by CBL.
