Pumped a preflush of 10 bbls mud clean and 10 bbls dye water ahead of 200 sx (282 cf - 50.22 bbl slurry) Type 3, 2% CaCl2, 0.25#/sx Cello-flake. Displaced w/25 bbls water. Plug down @ 1109 hrs 7/2/02. Circ. 15 bbls cement to surface. WOC. NU WH & NU BOP. PT rams, valves, manifold and casing to 250 psi low and 1800 psi high. Good test.
