Pumped a preflush of 10 bbls water, 10 bbls mud clean, & 10 bbls dye water ahead of Lead - 550 sx (1325 cf - 235.97 bbl slurry) Premium Lite High Strength FM, 3#/sx CSE, 3% Potassium Chloride, 0.4% FL-25, 0.25#/sx Cello-flake, 4#/sx Pheno-seal, 5#/sx Gilsontite.

Tail - pumped 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl₂, 0.25#/sx Cello-flake. Displaced w/146 bbls water. Plug down @ 1035 hrs 7/5/02. Circ. 30 bbls cement to surface. ND BOP, set slips and cut off casing. NU BOP, PT BOP equipment, rams, manifold-OK. PT casing to 250 psi low and 3000 psi high. Good test.
