Drill 12-1/4" hole to 280'. On 9/5/02 ran 6 jts. 9-5/8", ST&C, H-40, 32.3# casing. Set at 275'. Cement with 200 sacks (42 bbls) class B cement w/2% CaCl, 1/4# psx floeal, yield 1.19. Circulate 22 bbls cement to surface. **Pressure test casing to 1500 psi.**

Drill 8-3/4" hole to 3730'. On 9/5/02 ran 84 jts. 23# J-55 LT&C 7" casing. Set at 3720'. Cement with Lead: 470 sacks (121 bbls) 50/50 POZ 13.0#, yd 1.44. Foamed with N2 to 9.0 lbs, additives 2% gel, 2% versaset, 1% diacel LWL. Tail with 75 sacks (20 bbls) 50/50 POZ, mixed at 13.0#, yield 1.44, additives 2% gel, 2% versaset, 1% diacel LWL. Circulate 20 bbls cement to surface. **Pressure test casing to 1500 psi.**

Drill 6-1/4" hole to 8238. On 9/17/02 ran 4-1/2" 11.5# J-55 casing. Set at 8238'. Cement with 115 bbls 50/50 POZ, 2% gel, .15% versaset, .1% diacel (450 sx 1.45 cuft/sx) foamed cement, 58 bbls 50/50 POZ, 2% gel, .15% versaset, .1% diacel (225 sx 1.45 cuft/sx) unfoamed cement. Top of cement 4000'. **Pressure test casing to 4400 psi.**
