Drill 12-1/4" hole to 285'. On 8/7/02 ran 6 jts. 9-5/8" ST&C, H-40, 32.3# casing and landing jt. Set at 275'. Cement with 200 sacks (42 bbls) class "B" cement, 2% CaCl, 1/4# PSX Floseal yd 1.19. Circulate 20 bbls cement to surface.

Drill 8-3/4" hole to 3648'. On 8/12/02 ran 7" LT&C, 23#, J-55 casing. Set at 3638'. Lead slurry, 525 sacks (114 bbls) 50/50 POZ, 13.0#, yd 1.44, Foamed with N2 to 9.0 lb, additives 2% gel, 2% versaset, 1% diacel LWL. Start tail w/75 sx (14 bbls) 50/50 POZ, mixed at 13.0#, yd 1.44, additives 2% gel, 2% versaset, 1% diacel LWL. Did not circulate cement to surface. TOC 1250', temp. survey.

Drill 6-1/4" hole to 8060'. On 8/16/02 ran 4-1/2" J-55 LT&C, 11.6# casing. Set at 8060'. Cement w/lead: 465 sacks (120 bbls), 13ppg 50/50 POZ w/2% gel, .15% versaset, 1% diacel LWL, .13 gal P/sx foamer, yld 1.44, foamed w/N2 to 9 ppg. Tail in with 180 sacks (48 bbls) 50/50 POZ w/2% gel, .15% versaset, 1% diacel LWL, yld 1.44. Pump cap of 50 sacks (10 bbls), class B cement w/2% CaCl, 1% versaset, yld 1.18. Shut backside in. Circulate 45 bbls foamed cement to surface.
