Drill 12-1/4" hole to 300'. On 10/3/02 ran 6 jts. 9-5/8" ST&C H-40, 32.3# casing. Set at 290'. Cement with 200 sacks (42 bbls) class "B" cement. 2% CaCl, 1/4" psx flocele, yd 1.18. Circulate 20 bbls cement to surface.

Drill 8-3/4" hole to 3525'. On 10/10/02 ran 7" 23# J-55 LT&C casing. Set at 3515'. Cement with Lead: 475 sacks (123 bbls) 50/50 POZ, 13.0#, yld 1.44. Foamed with N2 to 9.0 lb. Additives 2% gel, 2% versaset, 1% diacel LWL, start Tail with 75 sacks (19 bbls) 50/50 POZ mixed at 13.0#, yld 1.44, additives 2% gel, 2% versaset, 1%diacel LWL. Circulate 60 bbls to surface.

Drill 6-1/4" hole to 8074'. On 10/15/02 ran 4-1/2" LT&C, J-55, 11.6# casing. Ran bow type centralizers on bottom three joints then every 5th joint for total of 15. Set at 8071'.

Cement with 585 sacks (153 bbls) 50/50 POZ, 3% gel, .% Halad 9, .2% CFR3, 5# gilsonite and 1/4" floseal. Did not circulate cement to surface. Top of cement at 6950' by CBL.

- Please provide documentation of remediation on the 4 1/2" casing.
