Drill 12-1/4" hole to 290'. On 9/19/02 ran 6 jts. 9-5/8", 32.3# H-40 casing. Set at 281'. Cement with 200 sacks (1.18 cuft/sx) class "B" 2% CaCl2 and 1/4" Flocele. Circulate 15 bbls cement to pit.

Drill 8-3/4" hole to 3640'. On 9/24/02 ran 7", 23#, J-55 LT&C casing, float collar & 82 jts. 7", 23# J-55 LT&C casing. Set at 3631'.

Lead: Cement with 530 sacks (137 bbls) 50/50 POZ, 2% gel, .2% versaset, .1% diacel, cement foamed to 9 ppg. Tail in w/115 sacks (30 bbls) 50/50 POZ, 2% gel, .2% versaset, .1% diacel. Circulate 65 bbls cement to pit.

Drill 6-1/4" hole to 8144'. On 9/30/02 ran 1 jt. 4.5# J-55 11.6# LT&C casing. Set at 8137'. Cement with 250 sacks (65 bbls) 50/50 POZ w/2% gel, .15% versaset. No circulation cement. Top of cement 5800'.
