Devon plans to sidetrack the Northeast Blanco Unit 321 at a depth of 7551'. While drilling the 6 1/4" hole at 7978', the drilling string parted and the fish was deemed non-recoverable. The top of the fish is at 7582'. A cement plug will be spotted from 7525' to 7582'. The plug will be dressed to 7551', and an articulated mud motor will be utilized to exit the original wellbore.
