Devon plans to perform a second sidetrack in the Northeast Blanco Unit 321 at a depth of 7350'. The first sidetrack attempt re-entered the original borehole at a depth of 7611'. A cement plug will be spotted from 7603' to 7300'. The plug will be dressed to 7350' and an articulated mud motor will be utilized to exit the original wellbore.
