Set 8-5/8" 23 ft./lb. casing @ 377'.

Cemented with 275 sx. (340.3 cu. ft.) class "B" cement with 3# Gilsonite & 1/4# celloflake/sx.

Had good returns, but did not circulate. Pumped 25 sx. (29.5 cu. ft.) Class "B" cement down annulus from the surface. Annulus filled and cement held at surface ok.

Pressure tested casing to 1,000psi; held with no leaks.
