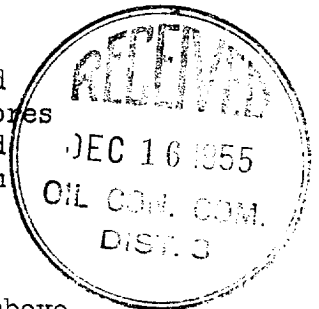

Reference is made to your letter of October 4, 1955, requesting permission to drill a test well for oil to the Farmington Sand, in the extreme northwest corner of the SE/4 SW/4 Section 34 30N-11W.
