Permanently plugged and abandon with a 72 foot plug in bottom, using 12 sacks of cement, 4 in formation, 8 in pipe, shutting off water. Put a 30 foot plug in top, using 5 sacks of cement. Leaving pits and location leveled and clean. Placed 4 inch marker 4 feet above ground level.
