13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. There is a real possibility that we would deepen this well to the Dakota formation, but only if the casing tests to 3000 psi. Plans are to set a CIBP above the openhole section of this well and then pressure test the well to 3000 psi. If the casing fails to test to 3000 psi, we will submit plans to P&A this well. If it passes this test we will leave the CIBP in place until we can work out the details of doing the Dakota completion, which will include getting it on our budget and getting partner approval.
