A successful casing integrity test was run 9/21/01 (see sundry dated 9/27/01). Phillips is still considering deepening this well in the future. Plans are to evaluate the NEBU and 32-8 Dakota development before we commit to recompleting this into the DK zone. Phillips wishes to extend the SI status approval for this well for up to two years, while the two areas mentioned above can be evaluated and funding can be received.
