Cement solid the Todilto and upper portion of Entrada, 2500' through 2537'.
Place 10 sz cement plug at bottom of Dakota, 1600' through.
Place 10 sz cement plug at top of Dakota, 1415'.
Place 10' cement plug in surface pipe and install 4" x 4' pipe with proper
inscription and location of well as required. 4" pipe 2' in cement.
Mud in hole - 9.2.
Verbal telephone approval given by Mr. A. R. Kendrick as of this date.

(We may go back into this well after drilling several more wells in the area)


