Vastar elected to reperforate and refrac the Fruitland Coal in the subject well in an attempt to increase gas flow rates. Reperforated Fruitland Coal fm 4141' to 4163', 22' w/ 4 spf adding 88 holes w/ 0.42" diameter and treated all perms w/ 1 000 gal 10 % formic acid followed w/ 105,718 gal 25# Delta frac 140 gel w/ sandwedge containing 2,210 sx 20/40 Brady sand. After cleaning out the 5 1/2" csg to 4222' (PBDT), a 1.9", 2.76#, J-55, 10RD IJ tbg assembly was run w/ an 'F' nipple and WL Re-entry guide. No pkr, EOT at 4146'. Flow and clean well to a flowback tank. Operator will set production equipment and return the well to production. Operations started on 05/17/2000 and were completed on 06/20/2000.
