Vastar elected to reperforate and refrac the Fruitland Coal in the subject well in an attempt to increase gas flow rates. Reperforated Fruitland Coal fm 3976' to 3997', 21' w/ 4 spf adding 84 holes w/ 0.42" diameter and treated all perfs w/ 1000 gal 10 % formic acid followed w/ 65,865 gal 25 # Delta frac 140 gel w/ sandwedge containing 1287 sx 20/40 Brady sand. After cleaning out the 5 1/2" csg to 4043', (PBDT), a 1.9", 2.76#, J-55, 10Rd IJ tbg assembly was run w/ a profile nipple and WL re-entry guide. No pkr, EOT at 3957'. Flowed and cleaned well to a flowback tank and returned the well to production. Operations started on 04/19/2000 and were completed on 05/02/2000.
