RU Halliburton & cemented with 570 sx 65/35 poz B with 6% gel, 10#/sk gilsonite, 1/2#/sk flocele & 1% CaCl2 (1.96 yield), followed with 100 sx 50/50 poz B with 2% gel, 10#/sk gilsonite, 1/2#/sk flocele & 2% CaCl2 (1.35 yield), (1252 cu. ft.). Plug down @ 5:30 am 7/8/00. Circ. 50 sx cement to surface. RD Halliburton. WOC. Tested casing to 1200 psi - OK.
