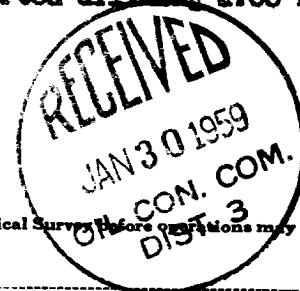

DETAILS OF WORK

This well was spudded 3:30 P.M., 1-21-59. Drilled 12-1/4" hole to 105' SLM. Ran 3 joints 8-5/8" O.D. 2 1/2 J-55 casing = 92.92'. Set at 100.93' and cemented with 115 sacks common cement plus 3% CaCl. Job complete 10:00 P.M., 1-21-59. Cement circulated. W.O.C. to 12:00 Noon 1-22-59. Nipped up BOP's. Tested 8-5/8" casing with 500# for 30 minutes, O.K. Started drilling 2:00 P.M., 1-22-59.
