**Plugging and Abandonment Procedure
Horseshoe Gallup Unit No. 199

Well Data:

Location: 1710' FSL, 2310' FEL, Section 33 T31N, R16W
San Juan County New Mexico

TD: 1350'
PBTD: 1316'

Surface Casing: 8-5/8", 22.7ppf, H-40 set @ 89' with 70 sacks

Production Casing: 5-1/2", 14ppf J-55 set @ 1344' with 80 sacks

Perforations: 1140'-1182' with 4SPF
1266' -1278' with 4SPF

Procedure:

1. Release packer and TOH w/tubing.
2. Trip in hole with cement retainer and set at 1000.'
3. Mix and pump 33 sacks of cement below retainer. Pull out of retainer and set 15 sack plug on top of retainer. Estimated top of cement to of cement @ 870'.
4. TOH and lay down tubing.
5. Perforate squeeze holes at 115'.
6. Establish circulation down casing, through annulus and out bradenhead.
7. Mix and pump 55 sacks of cement down casing through perforations, into annulus and out through bradenhead. Leave casing and annulus full of cement.
8. Cut off casing and install regulation dry hole marker.
9. Reclaim location as per BLM regulations.
