(Meridian)Blanco (Field) San Juan (County or Subdivision) New Mexico (State or Territory)The elevation of the derrick floor above sea level is 6611 ft.

DETAILS OF WORK

It is intended to drill a well with Rotary tools through the Mesa Verde, drilling the pay Section with gas circulation, and to shoot the entire Mesa Verde with two quarts of S.N.G. per foot. Total Depth 5770'.

Casing Program:

9 5/8" @ 160' with 125 sacks of regular cement circulated to surface
7" @ 5090' with 300 sacks of regular cement.

The E 1/2 of Section 31 is dedicated to this well.
