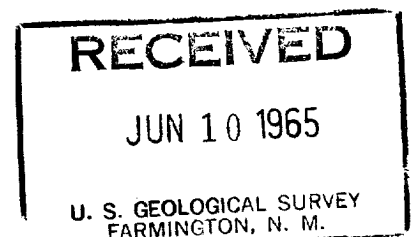
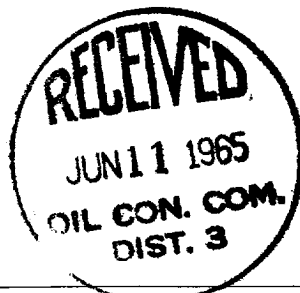

On 6-4-65 tested casing w/4000# O. K. Perforated Point Lookout 5700-18' w/2 SPF, 5650-54 & 5636-40' w/4 SPF. Frac w/36,800 gallons of water, 3# J-111/1000 gallons, 35,000# 20/40 sand. Max. pr. 3600#, BDP 2350#, tr. pr. 2600-3200-3500#. Dropped 2 sets of 16 balls each. Flushed w/4200 gallons water. I.R. 44 BFM. SIP vacuum.

Set magnesium bridge plug at 5350', tested w/3500# O. K. Perforated Cliff House 5190-94, 5164-68' w/4 SPF, 5145-54' w/2 SPF. Fraced w/24,260 gallons water w/3# J-111/1000 gallons, 24,000# 20/40 sand. Max. pr. 3000#, BDP 2600#, tr. pr. 2800-3000#. Dropped 2 sets of 16 balls each, flushed w/1600 gallons water. I.R. 47.5 BFM. Balled off after second drop. Pressured to 5000#, held 4000# for 7 minutes w/no breakdown.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
