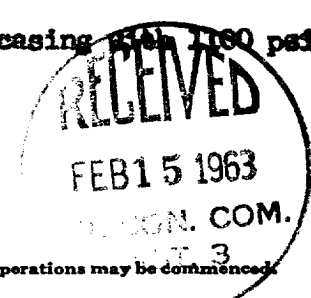

DETAILS OF WORK

Drilled 8 3/4" hole to 2774'. Ran 7" O.D. 20# J-55 casing with guide shoe and float collar (2766.35') set at 2775.20'. Cemented with 100 sx cement plus 8% gel and 25# Gillisonite per sk followed by 130 sx cement plus 4% gel. Plug down 6:30 pm 11-10-62.

Moved out rotary rig and W.O.C. until 1-11-63. Tested 7" casing with 100 psi on 1-11-63. OK.
