Reference is made to your letter of June 28, 1956, relative to your application for approval of dual completion on your #6 Heaton well, located in the NE/4 of Section 33, Township 31 North, Range 11 West.

This letter will constitute tentative approval of your plan as submitted, with the exception that you install a side door choke in the 2" tubing above the packer and subject to the provisions of Rule 112, Paragraph C. Upon completion of the well, application for final approval should be made to Mr. A. L. Porter, Secretary and Director of the Commission, Box 871, Santa Fe, New Mexico. The application should set forth pertinent facts of the completion and describe in detail how the well is equipped. Packer setting affidavit should also be submitted at that time, along with evidence that offset operators have been notified. Final approval will be granted by Mr. Porter after waiting the required ten days for objections from offset operators.

This is to inform you that the El Paso Natural Gas Company intends to dual complete our Heaton #6 Well located in the NE/4 of Section 33, Township 31 North, Range 11 West, San Juan County, New Mexico.

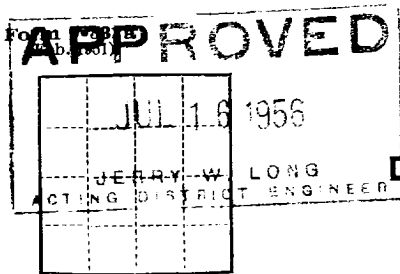
This well will be dually completed in the Pictured Cliffs formation and the Mesa Verde formation. This location is within the bounds of the Blanco Mesa Verde Pool and within one half mile extension of the Aztec Pictured Cliffs Pool. The dual completion will be a normal tubing annulus completion with a packer separating the production zones. Upon completion and running of Initial Potential packer and packer leakage tests, we will request administrative approval from the Oil Conservation Commission.

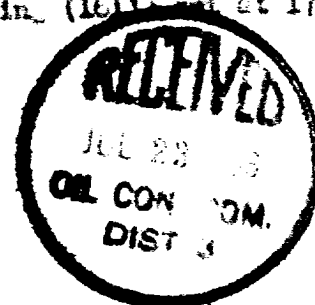
