DETAILS OF WORK

Moved in workover rig, killed well with salt water, pulled tubing, set Halliburton bridge plug at 5712'. Ran cement bond log and no indication of cement over zone. Perforated 5590-91' with four holes and squeezed 75 sacks cement. Re-squeezed perforation with 50 sacks cement. Cleaned out cement, jet perf. with one hole per foot 5547-54' and 5558-59'. Ran Halliburton KTS tool with retrievable valve tester set at 5520'. Recovered tools. Reset KTS packer and squeezed perforations 5547-57' with 50 sacks. Cleaned out cement. Re-ran 250 jts. of 2-3/8" 4.70# tubing, landed at 7432'. Installed Xmas tree and now snubbing well to clean prior to being S.I.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
