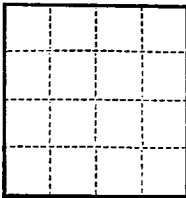

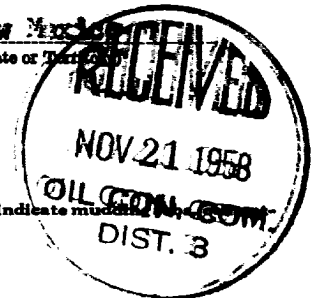

This well was spudded 12:30 P.M., 11-16-58. Drilled to 105' SLW. Ran 3 joints 8-5/8" J.D. 2 1/2" J-55 casing = 92.90'. Set at 100.90' and cemented with 115 sacks common cement plus 3% CaCl. Cement circulated. Plug down 5:00 P.M., 11-16-58. W.O.C. 12 hours, released pressure, nipped up BOP's. Tested casing with 600# for 30 minutes, O.K. Started drilling plug 9:00 A.M., 11-17-58. W.O.C. TOTAL 18 1/2 hours.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
