This well was spudded 9:00 P.M., 11-30-58. Drilled to 105' S.M. Ran 3 joints 8-5/8" O.D. 21# J-55 casing = 93.42'. Set at 101.32' and cemented with 115 sacks regular cement plus 3% CaCl. Plug down 5:00 A.M., 12-1-58. Cement circulated. W.O.C. 12 hours. Released pressure, nipped up BOP's. Tested casing with 600# for 30 minutes, O.K. Started drilling plug 9:30 P.M., 12-1-58.
