# Recompletion

**State Gas Com BC #1**

*Mesa Verde Recompletion*

## **Purpose:**

The following procedure plugs the Dakota formation which is unable to produce at economic rates and recomplete the Mesa Verde formation. A fish was lost in the hole and cannot be retrieved 6,763'.

## **Suggested Procedure:**

1. Set CIPB above fish 6,760.
3. Spot cement plug 100 ' above retainer to 6,660' with 10 sx.
4. Hydraulically pressure test Casing to 500 psi.
5. Perf Mesa Verde 4621-4710, 4810-4842, 4854-4890.
6. Fracture stimulate Mesa Verde formation with 150,000 # 20/40 Sand (Foam).
7. Land production string.
5. Flow test well.
