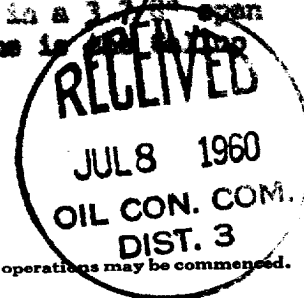

DETAILS OF WORK

Notice is hereby given of intention to drill the subject well. 8 5/8" casing will be set at 125' and cement will be circulated to surface. 4 1/2" casing will be set at approximately 4700' and cement will be brought up past the Point Lookout sand. Both strings of pipe will be pressure tested for leaks prior to drilling out cement. The well will be completed in a 3 7/8" open hole at a total depth of approximately 4850'. The pay zone is see log (Tecito).



I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

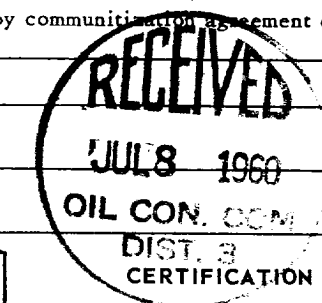
