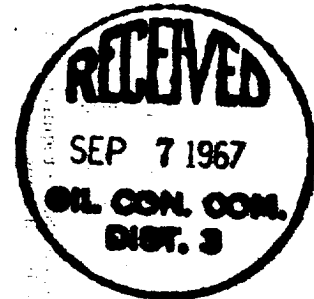

Request approval of the following plans to plug and abandon since oil is no longer producible in paying quantities and no workover possibilities exist:

- 255' plug w/27 sx cement 4595' to 4850' (T.D.) in 4-1/2" O.D. liner from 4607' to 4850' and in 5-1/2" 14# casing from 4595' to 4632'.
- 100' plug w/25 sx cement from 2770' to 2870' across 5-1/2" casing cut estimated @ 2820'.
- 100' plug w/34 sx cement in 7-7/8" open hole from 2105' to 2205' across top of Mesa Verde formation @ 2156'.
- 50' plug w/18 sx cement in top of 8-5/8" 24# surface casing.
- Heavy mud between all plugs.
- Steel marker w/4" pipe 4' above ground level.
- Clean up location.
- Estimate work to be done during September, 1967.
