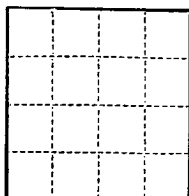

DETAILS OF WORK

This well was spudded 2:30 P.M., 1-25-59. Drilled 12-1/4" hole to 105' S.M. Ran 3 joints 8-5/8" O.D. 2 1/2" J-55 casing = 90.75'. Set at 98.80' and cemented with 115 sacks common cement plus 3% CaCl. Job complete 10:00 P.M., 1-25-59. Cement circulated, W.O.C. 12 hours. Nipped up BOP's. Tested casing with 550# for 30 minutes, O.K. Resumed drilling 2:00 P.M., 1-26-59.
