It is intended to workover this well in order to repair casing leak and to increase production; On a recent bradenhead test this well flowed water and gas indicating a probable casing leak.

It is intended to test 6 5/8" casing and repair any leaks, and/or to perf. and black squeeze the casing annulus in order to stop the bradenhead flow. The open hole section will be squeezed off and the Mesa Verde will be a redrilled in a sidetrack hole to avoid junk in the old hole. A full string of 4 1/2" production casing will be set and cemented. Selective zones in the Mesa Verde formation will be perforated and sand-water fractured.

Instructions
