- Pt_ Flowing wellhead pressure (tubing if flowing through tubing, casing if flowing through casing.) psia
- P_{f} Meter pressure, psia.
- $h_{\mbox{\scriptsize W}}\mbox{\small I}$ Differential meter pressure, inches water.
