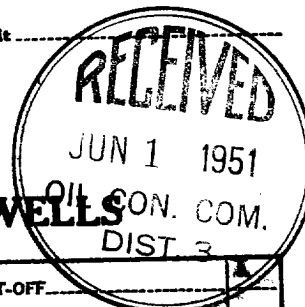

Run 1/2 in. (129') 40.50# 1-55, 1 in. (43'), 40.50# 55 B and 3 in. 32.75#
N-40 (79') of 10 1/4" OD casing for surface. Total pipe in well 251' set
at 260' (13) with 200 sacks of regular cement and circulated to surface.
Prior to drilling plug set, casing was tested with 500' pressure for 30 min.
with no drops after drilling out cement, safety was stopped, and fluid level
in casing was measured for any drop or rise; fluid level remained stationary.

Well spaced 5/26/52.
