DETAILS OF WORK

This well was spudded 5:00 P.M., 11-21-58. Drilled to 105' SLH. Ran 3 joints 8-5/8" O.D. 24 1/2 J-55 casing = 93.27'. Set at 101.77' and cemented with 115 sacks common cement plus 3% CaCl. Plug down 10:00 P.M., 11-21-58. W.O.C. 12 hours. Released pressure, nipped up BOP's. Tested casing with 600' for 30 minutes, O.K. Started drilling plug at 2:00 P.M., 11-22-58.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

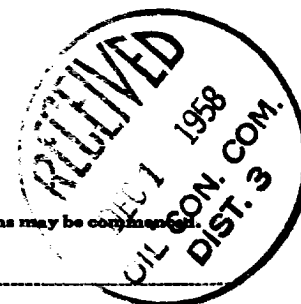
