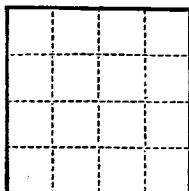

DETAILS OF WORK

This well was spudded 6:30 P.M., 1-11-59. Drilled to 104' SLI. Ran 3 joints 8-5/8" O.D. 2 1/2" J-55 casing = 93.67'. Set at 102.67' and cemented with 115 sacks common cement plus 3% CaCl. Cement circulated. Job complete 12:01 A.M., 1-12-59. W.O.C. to 12:00 Noon, 1-12-59. Hipped up BOP's and tested 8-5/8" casing with 550# for 30 minutes, O.K. Started drilling plug at 4:00 P.M., 1-12-59.
