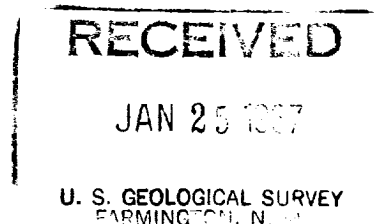

On 1/10/67 treated each zone w/mixture of butane and distillate to remove paraffin. Then treated each zone w/50 bbl. hot water + 5% detergent followed by 1000 gal. 15% Hcl. Swabbed back for cleanup. Set Baker Model A tension packer at 1277.75'.

On 1/12/67 started injecting water into lower zone thru 2" tubing and into upper zone thru casing tubing annulus.

Instructions
