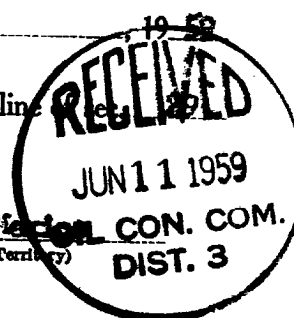

WOC 12 days. Tested casing with 500' 30 minutes, OK. Started drilling plug 1:00 PM, 5-25-59. Ran Induction ES and SP Sonic logs, their TD 1394'. Drilled to 1405' SLH. Ran 1/3 jts. 4 1/2" OD 9.5' J-55 casing = 1389.95'. Set at 1399.15' and cemented with 150 sacks Bostmix. Plug down 1:30 PM, 5-27-59. WOC 41 hours. Tested 4 1/2" casing with 1000' 30 minutes. OK. Ran Gamma Ray Correlation log, their TD 1362'. Perforated 1336-1343' Schl = 1334-1341' GR with 28 jets. Treated with 20,000' 10/20 sand in 12,726 gallons base crude. FED 2500-1200'. Average treating pressure 1300', average injection rate 27.2 BPI. Job complete 10:30 AM, 5-29-59. Perforated 1210-1218' & 1226-1235' Schl = 1208-1216' & 1224-1233' GR with 68 jets. Treated perforations with 50,000' 10/20 sand in 22,223 gallons lease crude. FED 2400-2400'. Average treating pressure 1400', average injection rate 27.8 BPI. Job complete 2:00 P.M., 5-29-59.
